Customers will experience download speeds of up to 10Mbps. DISH-nTelos Wireless high-speed Internet is available for \$29.99 per month when bundled with a qualifying package of DISH’s award-winning satellite TV service.

Hyde, CEO of NTELOS Holdings Corp. “We are excited to begin this important next step to the original trial by adding customers in select markets, which will allow both companies to further evaluate the viability of a full commercial launch.
