

West Virginia American Water Invests \$350,000 in Nitro Infrastructure Upgrades

Nitro, W.Va., (May 13, 2025) – West Virginia American Water is pleased to announce an infrastructure upgrade project in Kanawha County. As part of our ongoing commitment to providing safe, clean and reliable water service, the company will be investing approximately \$350,000 in infrastructure improvements in Nitro.

The project began the week of April 29th and includes replacing 910 feet of aging water main with 2-inch PVC main to help improve service reliability for customers by helping to reduce service disruptions and maintain water quality. This project will occur in Nitro on Kanawha Avenue from the 500 block down to Hickory Street.

Crews will work Monday through Friday between 7:00 a.m. and 5:30 p.m., and traffic restrictions will be in place during construction. The project is expected to be completed by the end of June, and the final street restoration will be completed in the summer of 2025.

This infrastructure upgrade project is part of West Virginia American Water's plan to invest more than \$104 million in infrastructure upgrades across the state in 2025. In addition, these projects help support the economic health of the communities served by West Virginia American Water. Economic impact studies show that for every \$1 million invested in water infrastructure, upwards of 15 jobs are generated throughout local economies.

Over the past decade, West Virginia American Water has invested over \$736 million, in infrastructure projects and capital upgrades to address aging infrastructure across the Mountain State, including more than 168 miles of new water main.
