

## West Virginia American Water Begins \$345,000 Infrastructure Investment Project on Market Drive

Charleston, W.Va., (July 29, 2025) – West Virginia American Water is pleased to announce a \$345,000 infrastructure investment project in Charleston. The project, located on Market Drive, began the week of July 21 and includes replacing 640 feet of aging pipe with 6-inch PVC main.

“Investments like this project on Market Drive are essential to maintaining a strong and sound infrastructure,” Wyman added. “They reflect our dedication to being a responsible steward of the water system and a trusted partner to the communities we serve.”

Crews will work Monday through Friday between 7:30 a.m. and 5:00 p.m., on Market Drive from Rosalie Drive to Burlew Drive. For the duration of the project, traffic restrictions will be in place. The project is scheduled to be completed by the end of September, with the final street restoration completed in the fall of 2025.

This infrastructure upgrade project is part of West Virginia American Water’s plan to invest more than \$112 million in infrastructure upgrades across the state in 2025, supporting the economic health of communities across the company’s service area. Economic impact studies show that for every \$1 million invested in water infrastructure, upwards of 15 jobs are generated throughout local economies.

Over the past decade, West Virginia American Water has invested over \$736 million in infrastructure projects and capital upgrades to address aging infrastructure across the Mountain State, including more than 168 miles of new water main.
