

## West Virginia American Water Invests \$285,000 in Princeton Infrastructure Upgrades

Princeton, W.Va., (September 3, 2025) – West Virginia American Water is pleased to announce a \$285,000 infrastructure upgrade project in Princeton on Highland Avenue.

“We’re excited to announce this \$285,000 project in the Princeton community,” said Scott Wyman, President of West Virginia American Water. “Continued investment in infrastructure upgrade projects are vital to providing safe, clean, reliable service to our customers. This project is another example of our commitment to the communities we serve.”

The project will take place on Highland Avenue from 8th Street to North 9th Street and is scheduled to be completed by the end of October. Final street restoration will be completed in the fall of 2025. Crews will work Monday through Friday between 7:00 a.m. and 5:00 p.m., and traffic restrictions will be in place for the duration of the project.

This infrastructure upgrade project is part of West Virginia American Water’s plan to invest more than \$112 million in infrastructure upgrades across the state in 2025, supporting the economic health of communities across the company’s service area. Economic impact studies show that for every \$1 million invested in water infrastructure, upwards of 15 jobs are generated throughout local economies.

Over the past decade, West Virginia American Water has invested over \$736 million in infrastructure projects and capital upgrades to address aging infrastructure across the Mountain State, including more than 168 miles of new water main.
