

West Virginia American Water Continues Venable Avenue Investment, Begins \$360,000 Infrastructure Project

Charleston, W.Va., (September 9, 2025) – West Virginia American Water is pleased to announce it is continuing its infrastructure investment in Kanawha City on Venable Avenue, beginning a \$360,000 project to replace 1,020 feet of aging pipe with 8-inch PVC main.

“We are pleased to continue our investments in Kanawha City on Venable Avenue,” said Scott Wyman, President of West Virginia American Water. “This continued investment builds upon a project we completed earlier this year on this same street, and will help ensure our customers in this community continue to have access to safe, clean, and reliable water.”

Work will take place on Venable Avenue from 51st Street to 49th Street. Crews will work Monday through Friday between 7:00 a.m. and 5:00 p.m., and traffic restrictions will be in place for the duration of the project. The project is scheduled to be completed by the end of October, with the final street restoration completed in the fall of 2025.

This infrastructure upgrade project is part of West Virginia American Water’s plan to invest more than \$112 million in infrastructure upgrades across the state in 2025, supporting the economic health of communities across the company’s service area. Economic impact studies show that for every \$1 million invested in water infrastructure, upwards of 15 jobs are generated throughout local economies.

Over the past decade, West Virginia American Water has invested over \$736 million in infrastructure projects and capital upgrades to address aging infrastructure across the Mountain State, including more than 168 miles of new water main.
