West Virginia American Water Invests \$390,000 in North Charleston Infrastructure

Charleston, W.Va., (September 23, 2025) – West Virginia American Water is pleased to announce it is beginning an infrastructure investment project in North Charleston on 31st Street, beginning a \$390,000 project to replace 660 feet of aging pipe with 2-inch PVC main.

"At West Virginia American Water, we're committed to building a resilient water system that our customers can rely on every day. This \$390,000 investment in North Charleston is a reflection of that commitment," said Scott Wyman, President of West Virginia American Water. "Projects like this not only strengthen our system's performance but also support long-term sustainability to continue providing safe, clean and reliable water."

Work will take place on 31st Street from the intersection of 1st Avenue to the intersection of 3rd Avenue. Crews will work Monday through Friday between 7:00 a.m. and 5:00 p.m., and traffic restrictions will be in place for the duration of the project. The project is scheduled to be completed by the end of October, with the final street restoration completed in the fall of 2025.

This infrastructure upgrade project is part of West Virginia American Water's plan to invest more than \$112 million in infrastructure upgrades across the state in 2025, supporting the economic health of communities across the company's service area. Economic impact studies show that for every \$1 million invested in water infrastructure, upwards of 15 jobs are generated throughout local economies.

Over the past decade, West Virginia American Water has invested over \$736 million in infrastructure projects and capital upgrades to address aging infrastructure across the Mountain State, including more than 168 miles of new water main.
