

## Following National Fire Prevention Week Illinois American Water Awards 112 Firefighter Grants

Belleville, Ill. (November 4, 2025) — More than \$110,000 has been awarded this year to 112 Illinois fire departments and districts through Illinois American Water's Firefighter Grant Program. Since the initiative began in 2010, nearly 1,200 grants totaling over \$1 million dollars have been granted to fire and emergency organizations serving customers in Illinois American Water's service area.
