\$34,000 in Grants to Support Hunger Relief at Five Indiana Food Distribution Centers

[Greenwood, Ind. November 20, 2025] – The [American Water Charitable Foundation](#), a philanthropic non-profit organization established by American Water (NYSE: AWK), the largest regulated water and wastewater utility company in the U.S., and Indiana American Water announced today that the Foundation has awarded \$34,000 in State Strategic Impact grants to five Indiana-based community food distribution centers. These organizations provide direct support for hunger relief efforts in their local communities.

The following agencies received funding:

- Food Bank of Northwest Indiana, Merrillville – \$10,000
- Second Harvest Food Bank, Muncie – \$7,000
- Catholic Charities of Terre Haute Foodbank – \$7,000
- Food Finders Food Bank, Lafayette – \$5,000
- Great Harvest Food Pantry, New Whiteland/Greenwood – \$5,000
