

## Boil Water Advisory Issued for Customers in Pennsylvania American Water's Pine Ridge System in Bushkill

### **Boil Water Advisory Issued for Customers in Pennsylvania American Water's Pine Ridge System in Bushkill**

**SCRANTON, Pa. (Feb. 11, 2026)** Pennsylvania American Water routinely monitors the conditions in the distribution system. Early this morning, a water shortage was discovered in our Pine Ridge system in Bushkill, indicating a leak in the distribution system and a loss of positive pressure. A loss of positive water pressure is a signal of the existence of conditions that could allow contamination to enter the distribution system through backflow by back pressure or back siphonage. As a result, we are issuing a boil water advisory for customers in the affected area.

**This notice applies to approximately 1,000 customer connections in Pennsylvania American Water's Pine Ridge system in Bushkill.**

**DO NOT DRINK THE WATER WITHOUT BOILING IT FIRST.** Bring all water to a rolling boil, let it boil for one minute, and cool before using; or use bottled water. You should use boiled or bottled water for drinking, making ice, washing dishes, brushing teeth and food preparation until further notice.

*Inadequately treated water may contain disease-causing organisms. These organisms include bacteria, viruses and parasites, which can cause symptoms such as nausea, cramps, diarrhea and associated headaches.*

These symptoms, however, are not caused only by organisms in drinking water, but also by other factors. If you experience any of these symptoms and they persist, you may want to seek medical advice.

Guardians of infants and young children and people at increased risk, such as pregnant women, some of the elderly, and people with severely compromised immune systems, should seek advice from their health care advisors about drinking this water. ### **What happened? What is being done?**

Pennsylvania American Water is bringing in water while investigations into system repairs are being made. The company is also collecting and analyzing additional water quality samples, including bacteria samples.

We will inform you when the corrective actions have been completed and you
