

West Virginia American Water Invests \$450,000 on North 3rd Street and Jefferson Street

Princeton, W.Va., (February 13, 2026) – West Virginia American Water is pleased to announce a \$450,000 infrastructure project in Princeton on North 3rd Street and Jefferson Street.

“We are continuing our infrastructure investment projects in the Princeton community,” said **Scott Wyman, President of West Virginia American Water**. “By continuing to invest in our infrastructure, we are continuing to invest in the communities we serve and provide safe, clean and reliable water.”

The project will take place on North 3rd Street from Lee Street to Jefferson Street, and on Jefferson Street from North 3rd Street to North 4th Street and entails replacing 1,100 feet of aging pipe with 6-inch PVC main. It is scheduled to be completed by the end of April, and the final street restoration will be completed in the spring of 2026. Crews will work Monday through Friday between 7:00 a.m. and 5:00 p.m., and traffic restrictions will be in place for the duration of the project.

This infrastructure upgrade project is part of West Virginia American Water’s plan to invest more than \$129 million in infrastructure upgrades across the state in 2026, supporting the economic health of communities across the company’s service area. Economic impact studies show that for every \$1 million invested in water infrastructure, upwards of 10 jobs are generated throughout local economies.

Over the past decade, West Virginia American Water has invested over \$805 million in infrastructure projects and capital upgrades to address aging infrastructure across the Mountain State, including more than 168 miles of new water main.
