Through the program, DaVita will offset 10,000,000 kilowatts of energy - enough to power DaVita's six largest corporate business offices for an entire year - through the utilization of renewable wind energy. The offset is the equivalent of removing 1,315 passenger vehicles from the road, or reducing the strain placed on local power grids by the amount of power consumed by approximately 1,000 American homes.

"Providing life-saving treatment for our patients requires adapting to the needs of an ever-changing world," said Misha Palecek, Divisional Vice President and DaVita Village Green™ Program Director. "Our patients expect high quality service and support, and we encourage our patients, caregivers, partners and the rest of the industry to join us in this important effort."
