G.I. Jobs Top 100 Military Friendly Employers among military awards received

While about 5,000 companies are eligible for the award, only 2 percent make the list.

Recent numbers from the Bureau of Labor Statistics show that the unemployment rate for veterans overall is lower than the national average; however, veterans who separated from service after Sept. 11, 2001, have a higher rate of unemployment than the national average. Female veterans separating from service after Sept. 11, 2001, have a particularly high rate of unemployment.

DaVita Chief People Officer Laura Mildenberger urges employers to appreciate the skills and experience military veterans bring to their civilian jobs.

"Men and women who have served in any military branch, or the National Guard or reserves, are a fantastic resource to any employer," said Mildenberger. "DaVita veterans are among the best and brightest teammates we have, and we feel very fortunate they chose DaVita for their post-military careers."
