

# The Everett Clinic Shareholders Approve Merger with DaVita HealthCare Partners

## Shareholders clear way for final agreement

EVERETT, Wash., Dec. 21, 2015 /PRNewswire-USNewswire/ -- [DaVita HealthCare Partners](#) (NYSE: DVA), a leading independent medical group in America and leading global provider of kidney care, and [The Everett Clinic](#), a nationally recognized physician group, today announced the clinic's stakeholders voted to approve [a previously announced merger plan](#). Under the agreement, DaVita HealthCare Partners will acquire The Everett Clinic. Financial terms were not disclosed.

"This vote is recognition of the significant value that DaVita HealthCare Partners brings to our shared vision of growth and innovation," said Rick Cooper, CEO of The Everett Clinic. "DaVita HealthCare Partners is not only investing in our patients, they are investing in our community."

Pending pre-closing activities, The Everett Clinic's 20 care sites north of Seattle will join DaVita HealthCare Partners' expanding managed care business, along with more than 2,200 teammates caring for more than 315,000 patients.

"The Everett Clinic's guiding principles align so well with our own – physician leadership, patient centered care, clinical focus," said Joe Mello, COO of HealthCare Partners. "We're honored their stakeholders approved of this combination and believe in our vision."

The transaction is expected to close on or around March 1, subject to execution of a final definitive agreement.
