Organization honored for its commitment to chronic opioid therapy

The WSMA established the William O. Robertson Patient Safety Award to recognize and share innovative patient safety initiatives in the ambulatory care setting. The award was named after WSMA Past-President William O. Robertson, MD, who was a champion for patient safety, risk management and quality improvement throughout his career.

"We have found The Everett Clinic's commitment to improving the opioid epidemic in this community to be innovative and effective in improving patient safety and quality of care," said Donna Smith, MD and president of WSMA. "We are proud to present this organization with our esteemed patient safety award and look forward to seeing how their success continues to drive positive change."

The Everett Clinic's internal efforts to curb unsafe opioid prescribing have been very successful; the number of clinical staff adhering to safe opioid best practices guidelines has increased over 45 percent year-to-date, illustrating the organization's dedication to the issue. The internal measures are based on best practice criteria for safe opioid prescribing and include seven individual elements derived from Washington State regulationsⁱ, including pain score, pain inference score, opioid risk tool, morphine equivalent dose, urine drug screen, prescription monitoring program and opioid contract/agreement.ⁱⁱ Each must be assessed for each patient identified as a chronic opioid user.
