

HealthCare Partners Opens New Medical Facility and Urgent Care Clinic in Downtown Los Angeles

Founding clinic of HealthCare Partners upgrades to new state-of-the-art facility

LOS ANGELES, Aug. 21, 2018 /PRNewswire/ -- [HealthCare Partners](#), a division of [DaVita Medical Group](#) and a part of [DaVita Inc.](#) (NYSE: DVA), today celebrated the opening of a new state-of-the-art medical facility and urgent care clinic in downtown Los Angeles at Washington Boulevard and Hoover Street. The new facility replaces the roughly 40-year-old founding clinic of HealthCare Partners and establishes a health care hub in the Pico-Union neighborhood on the west side of downtown Los Angeles.

"This is a major milestone for our medical group and the downtown Los Angeles community," said Jim Rehtin, California regional president for HealthCare Partners. "In the 1970s, a medical group that would become known as HealthCare Partners set out with a simple goal - to better serve patients by making health care more team-based and collaborative. That all started at 1025 W. Olympic Blvd. and ever since it has helped multiple generations in this community live healthier lives."

Less than one-and-a-half miles from its previous location on Olympic Boulevard, the new downtown Los Angeles facility relocated to a brand new, 60,000 square foot, four-story facility at 1120 W. Washington Blvd. The clinic is connected to a nine-story parking structure with no-cost parking available to patients. The facility accommodates a variety of patient care operations including:

"We are thrilled to have HealthCare Partners as the anchor tenant of Downtown West Medical," said Robert Hanasab, principal of Robhana Group. "We look forward to bringing additional healthcare providers to complement HealthCare Partners in our forthcoming next phases of the campus's development. We see this as the beginning of a healthcare hub of the downtown Los Angeles area."

Drawing on years of experience as well as input from current patients and HealthCare Partners' teammates (employees), the new facility is enhanced with the patient experience in mind while being reflective of the diverse local community it will serve. Multi-lingual signage and information is placed throughout the building and bi-lingual care teams are on site to assist Spanish speaking patients.

"Not only will the new facility bring much needed jobs and economic activity to the area, it will also bring valuable medical services to the Pico Union/University Park communities."
