We have currently identified a single Amazon reseller, BluTiger, selling counterfeit Avmacol®.

## **Steps consumers should take:**

We are treating these counterfeit products as a threat to your safety and well-being.

If you know or suspect your Avmacol® is a fake, stop using it and contact us through our Customer Service Center at 1-888-886-6442 or [ContactUs@nutramaxlabs.com](mailto:ContactUs@nutramaxlabs.com). We will send you a shipping label to return it to us at no cost and will replace it with an authentic bottle of Avmacol®.

It can be extremely hard to tell a counterfeit product from an authentic one, but among the red flags are misspellings on the label, slight differences in logos or other graphics, and differences in the appearance of product form (e.g. tablets or capsules).
