

CHICAGO (September 9, 2011) – Hyatt Hotels Corporation (NYSE: H) announced today that it has entered into an amended and restated credit agreement with a syndicate of lenders that provides for a \$1.5 billion senior unsecured revolving credit facility that matures in September 2016. This restates its existing \$1.13 billion facility which had been scheduled to mature in June 2012.

“We are extremely pleased to have secured this committed facility at more favorable terms, backed by a strong group of diversified banks,” said Harmit Singh, Executive Vice President and Chief Financial Officer for Hyatt. “Our strong capital base positions Hyatt to pursue our strategic goals.”
