The client had a significant need to build a flexible and robust data management platform that supports faster onboarding of data, advanced analytics and other reporting requirements. Cognizant leveraged Intelligent Data Works Cognizant's AI Data Foundry to accelerate the migration, reducing the delivery timelines by 30 percent and lowering the technical debt.
- A large U.S. entertainment client was looking to improve its fans' experience. Using data from social media sources including Twitter, YouTube and Facebook, the Cognizant team developed a Customer 360 platform that could analyze the data and provide the client with content recommendations to improve fan engagement.
