The proposed new campus, which will be completed in three phases by 2033, will entail an investment of Rs 1,583 crore (Rs 15.83 billion). The first phase, for which construction will begin in 2026, will house 3000 associates upon its completion in early 2029. The next two phases will increase the seating capacity to 8000.

The centre features a dedicated client experience centre and collaborative spaces to foster teamwork and is designed to accommodate over 1,000 associates based in and around Visakhapatnam.
