She is a graduate from the University of Pittsburgh School of Law and graduated summa cum laude with a bachelor's degree in politics and philosophy from the University of Pittsburgh.

The inaugural In-House Counsel Awards, established in collaboration with the Western Pennsylvania Chapter of the Association of Corporate Counsel, acknowledges the significant role in-house counsel plays in the success of a business enterprise, and recognizes those attorneys – or teams of attorneys – that use legal skills to achieve excellent business outcomes. In addition to the recognition, Stephanie and the other honorees will be featured in the Friday, May 19 issue of the *Pittsburgh Business Times*.
