Eighty-nine percent of Slate School's students receive significant financial aid, with 50% paying less than 25% of tuition.

"We are also extremely proud to support organizations that keep our communities happy, healthy, and safe. The branch will provide an array of consumer and commercial products and services along with wealth management products. Five full-time employees will staff the branch.
